A quorum was established by Cinda Kelley. President Jill Evans welcomes those present in person and virtually.

<u>Lyft Pass Presentation</u>: Grace with Lyft presented Lyft Pass for the Board to consider as an option to replace the current transportation. Passengers can use app to request ride to/from work. EID can pay for entire ride or pay for a pre-set portion but cannot pre-set locations/total ride cost. Q and A with Board.

#### **Financial Committee:**

<u>Financial Statements</u>: Kate LeGrand presents the financial statements. Board has no questions. Grant motions to accept the financials, Jill seconds, all approve.

#### **Business:**

<u>Workforce Transportation Cost Options:</u> Royal Transportation reached out to Cinda to discuss contracting directly with the EID Board which would save the EID 10% in admin fees charged by CIRTA. Board would need to provide CIRTA with 90-day notice. Board discussed providing notice while continuing to discuss options (Lyft Pass, Royal Transportation, other modes, etc.). Cinda suggests working with not-for-profits that are providing rides into the EID as well as schools/student internship programs.

<u>2024 Budget Review</u>: Cinda reminds Board that the Jaeger Building membership is to be canceled removing that line item from the 2024 budget. Budget reviewed by Board. Grant moves to approve budget, Jill seconds, Board approves.

<u>CIRTA</u>: Cinda presented the ridership data. Board agrees to suspend fares for a limited time in January 2024.

Marketing: Jaime Johnson presents 3Q23 marketing stats.
