A quorum was established by Cinda Kelley. President Jill Evans welcomes everyone. Evans asked for any corrections to the Consent Agenda. Grant Goldman asked if the Directors had approved the proposed slate of officers and new members at the October meeting. After a short conversation, Goldman recommended making the addition of the vote and approval during that meeting for tracking. The minutes will be amended and resubmitted at the next meeting. Goldman made a motion to approve the Consent Agenda with the noted amendment. Evans seconded the motion carried.

Evans asked to also address the new slate and if we could make any recommendations to fill the vacant officer positions. Cindy Abner was nominated to the Finance Committee and to serve as Treasurer. Evan motioned, member Robert Pfeffer seconded, and the motion was unanimously accepted. Jessica Saylor was nominated. Goldman motioned, Evans seconded, and the motioned carried.

Financial Committee:

<u>Financial Statements:</u> Kate LeGrand presented the financial statements. With no comments, Evans makes a motion to accept, Pfeffer seconds. The Board accepts the financial statements as presented.

Evans asked if the landowners who are delinquent are aware the EID assessment becomes a lien on their property. Kelley shared delinquent landowners did receive a call the first year but have not been contacted a second time. It was asked if the landowners receive notices from Hendricks County of their delinquency. It is unclear. Kelley agreed to

contact the county representative to determine if the landowners are contacted. If not, Kelley will reach out to those on the delinquent listing.

Business:

Kelley presented the <u>2022 Annual Report</u> providing a reminder of including the background, strategies, and reporting requirements. Jaime Johnson reviewed the marketing and company reports. Kelley presented and reviewed the Connector report. Kelley added the 2022 Year End Financial report will be added. Stephen Lindley motioned to accept the Report. Bill Kirchoff seconded, and motion carried. Kelley will combine the report information into one document and submit to Plainfield Clerk prior to Feb. 1st.

Reports & Updates:

With all reports being reviewed and discussed, Evans moved to Andrew Klinger for any town updates. Klinger introduced Alyssa Woolard again and indicated she would be attending the meetings in his absence or with him as time allows. Those present welcomed her and offered any assistance she might need in her new position.

Klinger shared the town is working on transit legislation. Legislation has been drawn up and could be heard as early as next week. Other communities are also interested and would join in supporting this legislation.

Klinger noted road upgrades will be occurring that will impact the EID traffic on Smith and Bradley roads.

Public Comments: The meeting was opened for public comment. No public comment was offered and closed.
